HIS 1300 The U.S. in Global Perspective: A Nation of Immigrants - Dr. Poor

Introduction to the history of the United States within a global context from 1776 to the present. Examines the ways a distinctly American society developed within larger patterns of world history. Themes explored may include nationalism; imperialism; revolution; concepts of democracy, freedom, and equality; migration and immigration; industrialization and economic systems; and global conflict, with special attention to immigration and national identity.

HIS 1300 The U.S. in Global Perspective: We're the Kids in America - Dr. deGraffenried

Introduction to the history of the United States within a global context from 1776 to the present. Examines the ways a distinctly American society developed within larger patterns of world history. Themes explored may include nationalism; imperialism; revolution; concepts of democracy, freedom, and equality; migration and immigration; industrialization and economic systems; and global conflict, with special attention to children's history & history of childhood.
